

LEWENDE HAWE VERTONINGS HOOGTEPUNT VAN 2007 SKOUPROGRAM

Die Windhoek skou wat Namibië se grootste landbou- en handelskou is, het van 28 September tot 6 Oktober 2007 plaasgevind. Produsente vanoor die hele land en ook Suid Afrika het saamgetrek om hul diere ten toon te stel, saam te gesels oor ontwikkelinge in die industrie en ook top genetiese materiaal te bekom op die stoetveiling wat deur Agra aangebied was.

Die skouvereniging het weer hul jaarlikse vertonersonthaal op 1 Oktober aangebied. Die geleentheid is ook deur Agra geborg. Peter Kazmaier, hoof uitvoerende beampte van Agra het in sy borgtoespraak gesê dat ten spyte van die alomteenwoordigheid van negatiewe ekonomiese faktore soos lae reënval syfers, onbekende mark vooruitsigte en die stygende petrol pryse, kan Agra met trots terug kyk op 'n landbou jaar wat vele hoogtepunte ingehou het en wat ons die voorreg gehad het, om deel van te wees.

Die skouweek was ook weereens gekenmerk deur verskeie kampioenskappe wat gehou is in die groot- en kleinvee afdelings. Agra het ook hier as borg ruim bygedra tot die sukses van hierdie kampioenskappe.

Dit is egter Agra se grootvee veiling wat op Vrydag, 5 Oktober 2007 by die Agra/Standard Bank Ring aangebied is, wat die week van lewende hawe vertonings op 'n hoogtepunt afgesluit het. Die skouveiling vir grootvee is weereens baie suksesvol deur Agra aangebied waarvan 39 diere van verskillende beesrasse verkoop is. Hierdie veiling het baie belangstelling

uitgelok, plaaslik sowel as kopers vanuit Suid Afrika het die veiling bygewoon.

'n Nuwe Namibiese prysrekord vir alle rasse en Suidelike Afrika rekord is opgestel waartydens 'n koper uit Suid Afrika, N\$135 000 betaal het vir 'n Simbra bul wat afkomstig is van die Rumba Simbra stoet van Hardus Breedt van Grootfontein. Die



bul, by name "Dollar" het die toekenning as Standard Bank Bul van die Jaar ontvang en is ook die vader van die Groot Kampioen van Kampioene, "Dorka", 'n Simbra koei wat ook afkomstig is van die Rumba Simbra stoet.

Die telers het vanjaar baie moeite gedoen om hulle beste kwaliteit diere op die skouveiling ten toon te stel. Beoordelaars het nie 'n maklike taak gehad tydens die beoordelings van die verskillende rasse en inter-ras kampioenskappe nie. Martin Sefferdt, 'n beoordelaar uit Suid Afrika het genoem dat die diere wat ten toon gestel is, van uitstaande kwaliteit was en dat elke dier, 'n wanner in eie reg is. Van Agra se kant wil ons alle vertoners en selfs telers wat hulle diere tydens die grootvee veiling te koop aangebied het, baie gelukwens met die uitstekende voorbereidings wat hulle deur die jaar gedoen het om top kwaliteit diere na die Agra skouveiling te bring.

Agra se handelsafdeling het ook weer vanjaar saam met Safari Den, Auas Vet Med, Auas Wholesalers en verskeie verskaffers uitgestal. Produsente het ook geleentheid gehad om direk met verskaffers van ondermeer veemedisyne en veevoere, te gesels.
